# CAMPAIGN HIGHLIGHTS IMPACT OF DOMESTIC VIOLENCE ON CHILDREN

(TOLEDO, OH – April 1, 2021) — A partnership among child-serving agencies, a local hospital and area media organizations is helping to raise awareness about the impact that domestic violence is having on children in Lucas County.

Lucas County Children Services (LCCS), the Family and Child Abuse Prevention Center (FCAPC), YWCA of Northwest Ohio, Mercy Health, WTVG-TV, Cumulus Media and Lamar are working together to remind Lucas County residents that, "Family violence doesn't just affect adults; chances are that kids are victims, too."

FCAPC reported more than 6,000 incidents of domestic violence in 2018, the most recent year for which data is available. Ninety-four percent of individuals charged with domestic violence in Lucas County that year lived in Toledo, and Lucas County far outpaced the number of cases in Cuyahoga (2,477), Franklin (3,481), and Hamilton (1,780) Counties<sup>1</sup>.

LCCS case data reported that one-third of all family cases opened each of the last five years listed domestic violence as a contributing factor for agency involvement, second only to drug abuse. Nearly 2,000 Lucas County children were confirmed to have been victims of child abuse or neglect in Lucas County in 2020. During that same period of time (calendar 2020), the FCAPC's Children's Advocacy Center served 424 children by providing counseling, therapy referrals, medical exams, and forensic interviews, according to Dr. Christie Jenkins, CEO.

The Ohio Domestic Violence Network reported that in the period between July 1, 2019, and June 30, 2020, there were 77 domestic violence cases with 109 fatalities across 29 counties in Ohio. Eighteen percent of the cases involved children at the scene, and four children died from injuries sustained in a domestic violence incident<sup>2</sup>. They YWCA reported a 33 percent increase in calls to its domestic violence crisis hotline from 2019 to 2020.

"Just a few weeks ago, we had children shot and killed as a result of family violence, said Robin Reese, LCCS executive director. "Parents who lack the resources to cope with stressful

situations, or to leave unsafe relationships, leave the door open for children to witness or become innocent victims of violent acts," she added.

The YWCA of Northwest Ohio, the only emergency domestic violence shelter in Lucas County, explains that young people who experience domestic violence at home experience difficulty at school, regressive behavior, withdrawal from friends and activities, or unruly behavior. Without help, boys go on to become ten times more likely to abuse a partner in adulthood, and girls become six times more likely to be sexually abused, compared to their peers, according to Lisa McDuffie, YWCA president and CEO.

The Centers for Disease Control (CDC), the American Psychological Association (APA), and Substance Abuse and Mental Health Services Administration (SAMHSA) agree that increased stress among parents or other adult caregivers is often a major predictor of physical abuse and neglect of children<sup>3</sup>. The addition of stressors brought by the recent COVID-19 pandemic has created more opportunities for friction between adults, as well as anxiety-driven behaviors in children that could lead to abuse and neglect.

The campaign includes electronic billboards, TV and radio spots, digital ads, a website ( lucaskids.net/campaigns-special-projects/) and information cards, and will be prominently featured during the month of April, which is Child Abuse Prevention Month.
