A RESOLUTION AUTHORIZING the Executive Director and Retained Counsel to accept the material terms of the Janssen Settlement Agreement pursuant to the One Ohio Memorandum of Understanding regarding the pursuit and use of potential opioid litigation settlement funds and consistent with the material terms of the July 21,

2021 Janssen Settlement Agreement available at https://nationalopioidsettlement.com/.

WHEREAS, the Children Services Board of Lucas County (herein "CSB") is an agency of Lucas County,

county formed and organized pursuant to the Constitution and laws of the State of Ohio; and

WHEREAS, the people of the State of Ohio and its communities have been harmed by misfeasance,

nonfeasance and malfeasance committed by certain entities within the Opioid Pharmaceutical Supply Chain; and

WHEREAS, the State of Ohio, through its Attorney General, and certain Local Governments and Agencies,

through their elected representatives and counsel, are separately engaged in litigation seeking to hold Opioid

Pharmaceutical Supply Chain Participants accountable for the damage caused by their misfeasance, nonfeasance

and malfeasance; and

WHEREAS, the State of Ohio, through its Governor and Attorney General, and its Local Governments and

Agencies share a common desire to abate and alleviate the impacts of that misfeasance, nonfeasance and

malfeasance throughout the State of Ohio; and

WHEREAS, the State and its Local Governments and Agencies, and CSB have drafted and previously

adopted a One Ohio Memorandum of Understanding ("MOU") relating to the allocation and the use of the proceeds

of any potential settlements described; and

WHEREAS, a settlement proposal is being presented to the State of Ohio, Local Governments and Litigating

Agencies by distributor Janssen to resolve governmental entity claims in the State of Ohio, consistent with the

material terms of the July 21, 2021 Janssen Settlement Agreement; and

WHEREAS, the One Ohio MOU would apply to the allocation and the use of proceeds resulting from the

Janssen Settlement Agreement; and

WHEREAS, in order to agree to the Janssen Settlement Agreement, CSB must approve execution of the

Settlement Participation Form, attached here as Exhibit A; and

WHEREAS, Board wishes to accept the material terms of the proposed Janssen Settlement Agreement (the

"Proposed Settlement):

NOW THEREFORE, BE IT RESOLVED BY THE CHILDREN SERVICES BOARD OF LUCAS COUNTY, OHIO.

Section 1. That the Children Services Board of Lucas County ("CSB") hereby accepts the Proposed

Settlement pursuant to the terms of the One Ohio MOU.

Section 2. That the retained special counsel Zoll & Kranz LLC is hereby authorized to accept the

Proposed Settlement pursuant to the terms of the One Ohio MOU on behalf of CSB via electronic signature.

Section 3. That it is found and determined that all formal actions of the Board relating to the adoption

of this resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and any of

its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal

requirements.

# **DIRECTOR'S ACTIVITY REPORT**

As was stated last month Ohio as is the entire nation is experiencing a serious placement crisis for children and youth in foster care. Very simply put there are not enough placement resources. Our current situation in Ohio is that on any given day children are literally sleeping in the local child protection building. This month I had the opportunity as a trustee of our PCSAO to meet in Columbus with ODJFS Director Matt Damschroder to discuss the current crisis facing Child Protection in Ohio. He has requested data/demographics on who the children are adding to our current crisis.

Public News Service Children Services is tasked with protecting the safety, well-being, and permanency of children and families, but some experts say it has not escaped its origins as a system that separates.

#### **OhioRise**

I continue to serve on the advisory council for OhioRise. This week Ohio Medicaid Director Maureen Corcoran addressed the group to discuss the just how groundbreaking OhioRise will be once it is fully implemented. She also gave us regards form Governor Mike DeWine.

#### **Foster Home Recruitment**

We have a new 30-second commercial for foster care recruitment. It is airing in the Levis Commons, Fallen Timbers, and Franklin Park movie theaters, and it will also air locally in the coming weeks. We also have a spot to recruit caseworkers, and longer versions of both videos that will be posted to our website.

# Family First/QRTP

As you know we are a pilot county for the role out of Family First Prevention Service Act in Ohio. As a result, we were notified this week that we will receive \$10,000 for our participation as a pilot county.

The state informed us last week that Ohio was granted a waiver that allows Children Services agencies to complete the Child and Adolescent Needs and Strengths (CANS) assessments on our youth that have been identified as needing Qualified Residential Treatment Programs (QRTP). placements so we can obtain IV-E reimbursement. At LCCS, we have 5 staff that are now certified and several more taking the CANS training while it is being offered for free. We are also collaborating with our surrounding county child protection agencies to assist each other in completing the assessments, in addition to service providers that are trained. It is important for us to collaborate with others to maintain good relationships and also because we may experience a time that we have so many CANS assessments to do that our trained staff do not have time because of their other job duties.

# **Holiday Gift Drive**

We are in the midst of our annual holiday gift drive. This year's drive is going better than expected. So far, we've had a bike build, Shred for a Toy day at Burger King, a drive-through, drop-off event at WTOL that netted 6,000 toys, and iHeart Radio's Toy-a-thon outside Franklin Park Mall. Toy-a-thon went on in spite of 60-mile-an-hour winds. We've also received generous contributions from Genoa Bank, La-Z-Boy, Hylant, DANA, Owens Corning, Toledo Streets, Bridges and Harbor, several local women's groups, and many more. We also had nearly 30 families sponsored by businesses, groups, and individuals. We've received a lot of very positive media coverage and community support. If there are extra toys, some will be stored here for birthdays and other special occasions; others will be shared with other area helping agencies like the YWCA and Kitchen for the Poor.

# **Diversity/Equity and Inclusion (DEI)**

We are working closely with Casey Family Foundation Consultants in the Development of the *Big Picture* for the Department. We are Leveraging Community Partnerships with other private and government DEI departments. In addition, we are closely watching the movement of Ohio SB 322 and 327 and adding our opposing voice to the discussion.

# This is contributed to the OCSS.

"Ohio House Bills 322 and 327 have been introduced, which would restrict the teaching of certain concepts and topics in K-16 classrooms. HB 322 primarily targets public schools and state agencies, but the Ohio Department of Higher Education would be included under the definition of state agency. This bill prohibits public entities from requiring discussion of current events and prohibits the teaching of a list of topics dealing with race, sex, slavery, and bias. It also targets history and civics courses, discouraging the discussion of current events, controversial issues, or activities that involve social or policy advocacy. Moreover, the legislation specifies that teachers cannot be required to teach anything that goes against their "sincerely held religious or philosophical convictions."

HB 327 is slightly different and more punitive than HB 322. The bill prohibits public schools, state agencies, colleges, and universities from offering teaching, instruction, or training on "divisive concepts" or accepting private funding to promote such concepts. Violations of the bill would result in the withholding of funding to school districts or State Share of Instruction to colleges and universities. The bill has a list of concepts related to race, sex, nationality, color, and ethnicity that it defines as divisive and therefore prohibited. It does say that divisive or controversial concepts can be taught if done so objectively and impartially, but who gets to determine what is objective and impartial is unclear."

#### DONATIONS/PARTNERSHIPS

The LCCS diaper bank received a large contribution from a drive held by the Anthony Wayne Area Democratic Club, which resulted in 30 cases of Pullups and ten cases of diaper wipes, items not received from the Salvation Army.

For the second holiday season, Vision Ministries is providing each child served by LCCS 12 and older with a gift card. The church and its partners raised the value to \$50 for each gift card this year, resulting in a donation of \$11,000+.

For the second straight year, the employees at Owens Corning world headquarters held an internal gift drive, which resulted in more than 1,000 donations of toys, books, coats, and winter gear.

The France Stone Foundation awarded Friends of LCCS a \$10,000 grant for the LCCS playground, raising it to a \$275,000 project. LCCS received three deliveries of play equipment in November weighing more than two tons total.
